WHEREAS, there is currently an Ex Parte Harassment Restraining Order in place and the Petitioner has asked for a hearing to challenge said Order;

WHEREAS, the parties have agreed to resolve the Harassment Restraining Order by reaching an agreement in this file;

WHEREAS, the Petitioner is not represented and has signed a Waiver of Counsel and Respondent is represented in these proceeding by Amie Ascheman of the Runchey, Louwagie & Wellman PLLP;

THEREFORE, THE COURT ORDERS AS FOLLOWS

1. Husband shall not have contact with Wife except for the following:

During exchanges.

Texts only regarding the children.

Phone calls only regarding the children. If a party does not Answer the phone, the party calling shall leave a voicemail; but shall not call the non-answering party again that same day.

2. Husband shall not come to Mrs. Jimenez residence or place of work; however, if agreed to in writing Husband shall have access to the shop for the times set.
3. Husband shall not pick up the children from school/daycare aside from during their agreed upon parenting time or as agreed to in writing

4. If Husband violates the terms of contact in this Order, said violation shall be a basis for a Harassment Restraining Order regardless if the definition of harassment was met.
5. Once this Order is signed, Wife shall dismiss the Ex Parte Restraining Order.
